**NOT INCLUDED IN PRICE:**

Airfare, passports, visa/ETA, vaccinations (if required), laundry, lunches not on the tour menu (food outside the contracted menu will be billed prior to leaving the hotel or restaurant), excursions not listed, telephone/international data, mini-bar, alcohol, other beverages, airport transfers on non-qualifying flights, portage at airports, excess baggage fees, additional airline fees after registration, travel insurance, and all other items not explicitly mentioned.

**PAYMENTS & FEES:**

**A non-refundable deposit of \$500 per person is due upon registration, with a second deposit of \$1,000 per person required within 21 days thereafter.**

Credit cards are only accepted for the initial \$500 deposit; subsequent payments must be in check, ACH transfer, bill payment, or wire transfer;

**all payments are required in US Funds.**

**Final payment is due no later than 150 days prior to departure.**

Registrations after 150 days require full payment and may incur a \$300 late fee if received 149-120 days before departure. **Failure to make final payment by 120 days prior to departure results in automatic cancellation, forfeiture of the \$1,500 deposit, and potential additional fees.**

imagine Tours and Travel, LLC (hereafter referred to as *imagine*) reserves the right to impose a surcharge if the dollar declines by more than 2% against the destination currency based on booking date (05/11/26).

**GROUP SIZE & SUPPLEMENTS:**

Tour pricing assumes a minimum group size of 20 passengers.

**Smaller groups may incur supplements:**

- \$245 per person (19-16 travelers)
- \$295 per person (15-12 travelers)
- \$395 per person (11-10 travelers)

Tours with fewer than 10 travelers may be canceled due to insufficient participation.

**ACCOMMODATIONS:**

Price is based on double occupancy (two people sharing a room).

Single rooms may be smaller than double rooms and, when available, incur an **additional supplemental charge of \$2,295 for the basic itinerary.** Roommates are assigned if available; otherwise, single-room occupancy may apply. Roommates may be assigned as late as 120 days prior to departure when applicable. Single rooms are limited to 10% of the total group size.

**ITINERARY & CHANGES:**

*imagine* reserves the right to adjust itineraries due to airline schedule changes. Changes requiring extra nights incur \$195 per person per night (\$295 for single rooms). You will be notified in writing of said changes when possible. Meals for additional overnights are not included. Changes and/or deviations from the program and/or departure city listed by the passenger must be provided in writing no later than 120 days prior to departure.

**All deviations are subject to a \$250 administrative fee** plus applicable airline fees. **All tours are made final at 120 days prior to departure.**

**No changes (including additions) may be made after this time.**

**LAND ONLY:**

**Land Only price is \$5,645 per person, excluding international flights.**

Land Only passengers may be responsible for transfers and/or additional overnights incurred by booking their own flights. Passengers changing from the regular tour (with group airfare) to Land Only after 120 days prior to departure will be charged a fee of \$195 per person.

**AIRLINE TICKETS & SEATING:**

Flight routing is at the sole discretion of the airline, not *imagine*. *imagine* does not guarantee passengers will be on the most direct flight or flying together to the final destination (especially prior to 120 days of departure). Flights are economy class on IATA/ARC carriers with non-refundable, non-amendable tickets for groups of 10 or more. Group airfare pricing is based on the original group air contract secured by *imagine*. Once contracted air inventory has been filled, any additional airfare secured for passengers—whether due to late registration, post-final payment additions, or changes requested by the passenger—**may be subject to increased costs**, which are the responsibility of the passenger. As such, *imagine* cannot guarantee that all travelers will be booked on the same flights, particularly for passengers added after the final payment deadline as outlined in *PAYMENTS & FEES*, if airfare is applicable. Due to group rates, *imagine* does not participate in or allow passengers to use points, miles, vouchers, or other airline-related programs on group contracted airfare. Seat upgrades, cabin/class upgrades, or paid seating enhancements are not available through *imagine* on group contracted airfare. All airfare provided under group contracts is economy class only. Seating requests are at the discretion of the applicable airline and cannot be guaranteed. All requests, including seating, dietary restrictions, and/or other accommodations must

be made in writing prior to 120 days of departure. Any specific requests regarding seat assignments, seat upgrades, or cabin/class changes must be handled directly with the airline if permitted under the airline's fare rules once tickets have been issued, and remain subject to airline policies, availability, and additional fees. *imagine* is unable to request, manage, or guarantee these changes on behalf of the passenger. Airline changes, if allowable, made by the passenger after 120 days prior to departure will incur additional fees. Individual ticketing fees and/or deposits may apply in certain situations. **These fees can be up to \$2,000 per person and will be applied to the final balance.**

**FLIGHT TIMES:**

**All flight times are subject to change without notice. *imagine* is not liable for expenses resulting from flight delays or changes.** If making your own flight arrangements to a departure city or any other portion of your trip, we recommend obtaining a ticket which can be changed without large penalties. All passengers are responsible for reconfirming their flights with the airline 24 hours prior to departure.

**PASSPORTS & VISAS:**

Passengers must ensure their **passports are valid for at least six months beyond the return date of their trip** and submit a valid passport copy to our office no later than 120 days prior to departure. Visa requirements vary by country, and it is each passenger's responsibility to obtain necessary visas prior to travel. *imagine* is not liable for obtaining any required travel visas.

**TRIP RESCHEDULING:**

*imagine* and/or the group leader/organization reserves the right to reschedule the trip to **future dates and/or a different destination** due to governmental action, pandemics, wars, or other circumstances beyond their control. Travelers unable to travel on the new dates or to the updated destination may transfer to another tour within one year of the original travel dates, subject to fees of up to \$300 per person, plus any applicable fees imposed by ground operators, airlines, or other vendors.

**CANCELLATION FEES:**

Passengers cancelling from the day of registration up to 151 days prior to departure **will be charged a \$500 administrative fee** plus any airline penalties, if applicable. If passenger cancellation forces a roommate into a single room, the canceled passenger will be charged the single room fee. ↓

We advise purchasing travel insurance.** In the event *imagine* cancels the tour due to insufficient participation, a \$200 administrative fee per passenger will be deducted from any applicable refund, plus any airline penalties. **Changes to the tour cannot be made within 120 days of departure, as the tour is considered closed at that time.**

# The ITINERARY

## Day 1 – Tuesday, April 20: Depart U.S.A.

Tour members make their own flight to Porto. After boarding the flight, travelers will be served meals according to airlines schedules. Sit back, relax, and enjoy the on-board entertainment.

## Day 2 – Wednesday, April 21: Medieval Wonders and Embarkation in Porto, Portugal

After landing at Porto Airport, we will have one group transfer to our port to board the A-ROSA ALVA River Cruise, our floating hotel for the next 7 nights. Here, we will meet the crew for a warm welcome dinner as our river cruise begins.

## Day 3 – Thursday, April 22: Baroque Lamego and Vineyard Dining

As the ship sails east, we enjoy the morning views of the “River of Gold.” In the afternoon, we visit the picturesque town of Lamego to admire its stunning Baroque cathedral and famous tiled staircase. The day concludes with an authentic Portuguese dinner at a traditional Quinta estate, where we will enjoy fresh local flavors tucked high among the hillside vineyards of Pinhão.

## Day 4 – Friday, April 23: The Heart of Wine Country

Spend the morning in the charming village of Pinhão, the epicenter of the region’s winemaking tradition. After a curated tasting of premium Port wines among the vines, return to the ship to continue sailing toward the Spanish border. The afternoon is yours to relax on deck as the river twists past terraced slopes and hilltop villages.

## Day 5 – Saturday, April 24: The Golden City of Salamanca

Travel across the border for a full-day immersion in Salamanca, one of Spain’s most beautiful cities. Discover the grand Plaza Mayor, the historic university, and the “House of Shells” while enjoying the local Spanish atmosphere. Our visit includes a traditional lunch at a local restaurant and free time to explore the city’s elegant boutiques and historic squares.

Explore the castle ruins and walk the narrow streets to find preserved traces of the ancient Jewish quarter before returning to the ship for lunch.

## Day 7 – Monday, April 26: Mateus Palace and Grand Gardens

Explore the 18th-century Mateus Palace, a masterpiece of Baroque elegance and one of Portugal’s most recognizable landmarks. Tour the ornate halls filled with original period furniture and art collections, then wander through the world-renowned gardens featuring manicured cypress tunnels and classical fountains. Afterward, we sail back toward the coast for our final approach to Porto.

## Day 8 – Tuesday, April 27: Porto, Fado, and Traditions

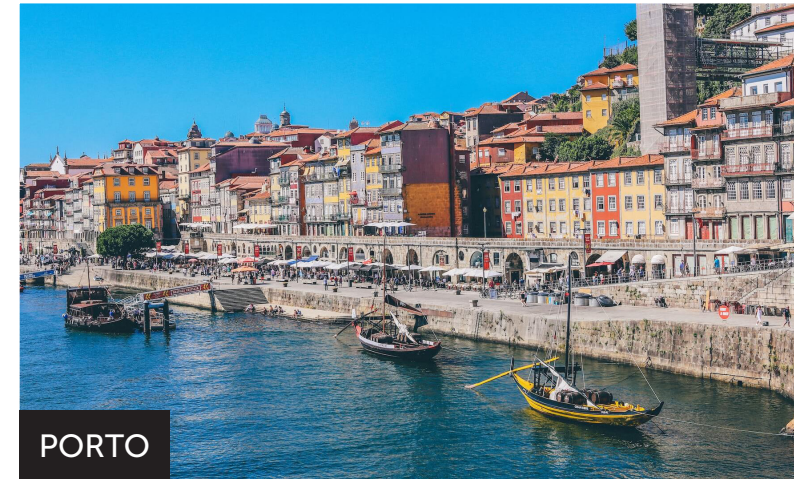
